#### WORK SESSION

##### FY 2022-2023 Proposed Amended Budget Update

David Horner, Chief Financial Officer, presented an update on the FY 2022 - 2023 Proposed Amended Budget. District 60 and District 70 enrollment data and projections were reviewed. The forecast for D60 enrollment is projected to decline while D70 enrollment is projected to increase and mirrors the state. Since 1995, the Pueblo County population has grown by 30% and the Pueblo City population has grown by 11% yearly. Over the past seven years, Pueblo County population has grown 3% and Pueblo City population has grown 2%. The D60 enrollment data showed a decrease of 173 students (K-12) from SY2021-2022 and a decrease of 208 students (K-12) over the past 2 school years.

CFO Horner reported that the FY2022-2023 amended budget document is pending the completion of the audit. The audit was due to the state on December 31, 2022, but the

delay in receiving the audits from the two D60 charter schools (Pueblo Arts & Sciences and Chavez Huerta K-12 Preparatory Academy) has caused the District to request a 60-day extension to March 1, 2023, which has been granted.

Further, CFO Horner review the General Fund Budget Summary, which indicated a estimated Beginning Fund Balance of \$31,045,771, which included the assigned operating reserve per Board policy of 6% and TABOR of 3%.
